

SLIGO COUNTY COUNCIL CONTRIBUTIONS TO THE ARTS GRANTS SCHEME FUNDING POLICY, CRITERIA, TERMS & CONDITIONS 2020

Arts Venues & Organisations

The objective of the Scheme is to support the <u>professional</u> arts sector in Sligo to play a distinctive role in developing a vibrant and sustainable arts environment at a local, regional, national and international level in partnership with Sligo County Council.

An annual programme of events and activities should present new ideas and ways of working that can have far reaching effects for artists and audiences.

Arts Festivals & Events

The Objective of the Scheme is to support Festivals and Events that promote public engagement with the arts as their core aim.

A festival may represent one art form or may include a wide variety of different art forms. Festivals or events may also be programmed over a number of months (e.g. a concert series).

Sligo County Council recognises the valuable contribution made by active voluntary committees in developing and sustaining festivals and events.

Eligible for funding:

- Artist Fees (this includes performance fees).
- Audience development (activity carried out to help organisations develop ongoing relationships with existing and new audiences).
- Travel Costs and Expenses for artists/performers.
- Venue Hire and related expenses.

Organisations, Events and Activities ineligible for funding

- Commercial organisations which share out profits to members.
- Annual running costs of a voluntary arts organisation.
- Competitive events e.g. where the competition is the dominant element of the programme, with the exception of Feis Ceoil, Feis Shligigh, Sligo County Fleadh and the Fiddler of Dooney competition.
- Once-off academic conferences/symposia with no wider public benefit.
- Charity/fund-raising events.
- Festivals or events that have taken place before mid March 2020.
- Events/Activities that are not arts-related (e.g. heritage, commercial, crafts, sport, food fairs).
- Individual artist's projects, exhibitions, performances etc.
- Group artists' projects, exhibitions, performances etc.
- Activities taking place in a formal education setting where the activity does not primarily engage with the wider community.
- Training programmes for individuals.
- Marketing and Publicity.
- Duplication of activities carried out by Sligo County Council.

CRITERIA FOR ASSESSMENT

Venues and Organisations

- All previous conditions of funding are fully and satisfactorily met.
- Professionally operated on a full-time basis.
- Quality of artistic programme.
- Evidence of strategic development.
- Accessibility for diverse audiences and participants in terms of location, cost, people with additional needs and young people.
- Demonstrated commitment to growing and diversifying audiences and deepening public engagement.
- Significant contribution to artistic and professional development of artists.
- Contribution to the professional development of local artists.

Festival and Events

- All previous conditions of funding are fully and satisfactorily met.
- Festivals and events for which arts activities are at the core of their programme.
- The potential for the project to stimulate public interest in the arts; promote the knowledge, appreciation and practice of the arts or assist in improving the standards of the arts.
- Supports the festival or event to engage professional artists (all artforms) including local artists where appropriate.
- The applicant can demonstrate that there is a need and demand for the festival or event.
- The applicant can demonstrate that the festival or event has clear aims and objectives, is well planned, publicised and managed and represents value for money.

TERMS AND CONDITIONS

- Governance:
 - If the organisation is a Company Limited by Guarantee it must be in compliance with the Companies Act 2014.
 - If the organisation is a charity, it must be registered with the Charities Regulatory Authority.
- Demonstrate sound financial management. Audited accounts must be provided where grants are in excess of €10,000.
- Assistance will be given only in respect of specific activities commencing after mid March 2020 and not towards retrospective activities or the payment of past debts. Payment of grant aid will be made on receipt of written acceptance of a grant offer and on agreement of a Memorandum of Understanding if this is required as a condition of funding.
- Grant aid provided by Sligo County Council must be acknowledged in all publicity material
 associated with the project/organisation. We reserve the right to publicise the awarding of
 the Contributions to the Arts Grants. Successful recipients will receive details regarding use of
 logos and acknowledgement.
- All funding applications are considered on an annual basis.
- All recipients of grant assistance for projects involving children or young people must have appropriate policies in place in relation to Child Protection.
- All projects must have evidence of adequate and comprehensive Public Liability Insurance.
 Sligo County Council accepts no responsibility and concedes no liability in respect of any accident, injury or damage to property or person however arising regarding any incident, occurrence or claim which may take place.

- Applicants in receipt of public funds must provide a tax registration number. The Tax
 Clearance Access Number and Tax Reference number must be submitted to the local
 authority for verification purposes when funds are being drawn down. See

- All applicants will be advised of the Council's decision in writing.
